


The Baltic Sea

- The youngest sea on our planet
- The brackish sea with both salt and fresh water
- Surrounded by 9 countries huge drainage area (4 times as large as the sea itself)
 -> pollutants released into the water remain there for a long time
- Large differences in salinity from 25 ppm to 2 ppm
- Partly covered by ice during winter

Baltic ecosystem is very unique









The Baltic Sea – ice conditions



The Baltic Sea is known to be one of the northernmost seas of Europe which freezes every winter contrary to the Norwegian and North Seas located at similar latitudes.




Baltic sea – ice condition for shipping





A passenger ferry **Amorella** had 753 passengers and 190 crew on board. The 10-deck ship belongs to Viking Line, which operates Baltic Sea cruises between Sweden and Finland.









The Baltic Sea – shipping

- One of the most shipping-intensive marine areas in the world, up to 15% of the world's cargo transportation
- About 200 ports (excluding small recreational ports) are crucial points in the international flow of goods
- 2 000 ships at any given moment and each month around 3500 – 5000
- Over 60.000 ships pass through Kattegat into the Baltic Sea every year





Baltic Sea/North Sea regional regulations






Baltic Ports Organization

- Established on October 10, 1991, in Copenhagen
- Nearly 50 members major ports in the nine countries surrounding the Baltic Sea
- Well-recognized within the BSR, in EU bodies and other international organizations
- Registered in Estonia (Port of Tallinn headquarter) and operates according to the Estonian Law on Non-profit Associations.
- Office in Gdynia, Poland

BPO Strategy for 2017-2019

The BPO's mission is to contribute to sustainable development of maritime transport and the port industry in the Baltic Sea Region, thereby strengthening its global competitiveness.

BPO Strategy for 2017-2019

BPO Areas of activities (examples):

BPO should represent the interests of the Baltic Sea ports towards EU institutions and other relevant organizations (e.g. Helsinki Commission).

BPO should contribute to the clean environment of the Baltic Sea, promote environmental management in the ports and play an active role in international dialogs where the environment is concerned.

BPO should promote Baltic Sea a model region for green ports and maritime transport. A part from promotion purposes, the idea of applying the same regulations in all Europe and worldwide, avoiding a distortion of competition in maritime transport, should be promoted as well.
